ORDER

Change of Premises of the Institution

WHEREAS, Sri Ramkrishna College of Education, Plot No. 548, Vill.- Belum, P.O.- Ashudkola, Tehsil/Taluka- Goghat, Town/City- Bengai, Dist.- Hooghly, West Bengal - 712611 (B.Ed.) (Code No. ERCAPP97/2012) granted recognition for conducting B.Ed. Course with an annual intake of 50 (one basic unit) from the academic session 2015-2016 vide order dated 31.05.2015.


2. AND WHEREAS, the aforesaid institution had submitted application dated 14.05.2019 for shifting of premises along with requisite documents.

3. AND WHEREAS, the ERC in its 274th meeting held on 15th – 16th July, 2019 decided that VT be constituted for shifting of premises. Accordingly, the inspection of the institution at new premises was conducted on 30/08/2019 and Visiting Team Report received at ERC, NCTE on 03/09/2019.

4. AND WHEREAS, the ERC in its 283rd meeting held on 24th – 25th August, 2020 after considering and examining the application alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and Visiting Team Report (VTR) for shifting of premises, were carefully considered by ERC and the committee decided as under:

- “Shifting of the institution to its new premises i.e. Sri Ramkrishna College of Education, Vill./P.o.- Bikrampur, P.S. – Simlatal, Dist- Bankura, West Bengal – 722151 is permitted.”




